The Gilded Age and American Impressionism (1880–1920)

In 1873 Mark Twain wrote "The Gilded Age," a book that would define and satirize a period of new wealth and prosperity emerging in America. During the next four decades, artists like Childe Hassam, William Merritt Chase and Matilda Browne would celebrate landscapes, still life and portraits in brush strokes of vivid color and compositions infused by natural light in the French Impressionist style now embraced by American artists. Because of Florence Griswold, whose stately sea captain's mansion became the boarding house for many of these artists, the Old Lyme art colony would become the home of American Impressionism in the first decades of the 20th century as artists discover and paint its unspoiled New England landscapes and natural beauty from the shoreline to rural farm fields.

Art Lecture Presenter Bob Potter attended college at Syracuse University's School of Visual and Performing Arts and spent his early career as an art director and creative director for leading media companies including Scholastic Magazines, Time Warner, and National Geographic. Over the past decade, he helped create an arts therapy program for Save The Children, was a corporate development officer for The National Gallery of Art in Washington, DC, headed marketing for Mystic Seaport and most recently is a docent at the Yale Center For British Art. He and his wife Jeanne, who is an artist, live in Old Lyme, Connecticut.

NOTE: Members attending the virtual Annual Meeting on May 5 will vote on these Bylaws revisions, the proposed 2021-2022 Budget (page 6), and the proposed slate (page 7).

The following is a summary of the proposed changes to the YUWO Bylaws, as voted upon by the YUWO Board:

Article III. MEMBERSHIP Membership shall be open to any person who by virtue of individual or family affiliation, past or present, is associated with the Yale community [leaving the remainder of the article as is]
[Purpose of change: To avoid likelihood of government concern and investigation.]
* * * * * * * * * * * * * * * * * * * *
Article V. OFFICERS Section 1. Elected Officers
C. Duties 1(a). The president shall preside at all meetings of the organization and the governing board. The president shall select all appointed and special officers with the approval of the governing board and shall serve as an ex officio member on all committees with the exception of the nominating committee. [Remainder of Section 1. remains as is]
[Purpose of change: Clarification of president's duties; not a substantive change.]
* * * * * * * * * * * * * * * * * * * *
2. Elected officers shall perform other duties, as listed in the most recent YUWO job descriptions and as designated by the Board.
[Purpose of change: To clarify where "other duties" may be found.]
* * * * * * * * * * * * * * * * * * * *
Section 2.A.: Officers with responsibility for functions or programs with organization-wide focus will be appointed by the president. These shall include Lecture Series, Lunch and Learn, Newcomers, Newsletter, Publicity, and other appointed officer positions as may be needed, subject to approval by the board.
[Purpose of change: To substitute Lecture Series, the current name, for Study Group.]

Section 3. Special Officers A. Definition Special Officers are individuals, such as an Excursion chair, Explore New Haven chair, Information Technology specialist, or Webmaster], who perform specialized tasks[leaving the remainder of the definition as it is]

[Purpose of change: To remove Archivist/Historian or a Parliamentarian since such a position has not

been occupied recently.]

B. Duties

Special officers shall perform those duties set forth for their positions as listed in the most recent YUWO job descriptions and as designated by the board.

[Purpose of change: Similar to V.1.C.2. above, to clarify source of duties.]

Article X. YUWO SCHOLARSHIPS FOR CONTINUING EDUCATION

. . .

Section 2. Eligibility

An applicant must be associated with the Yale community, by either her own or her family's affiliation. [leave the rest of the section as it is]

[Purpose of change: To broaden women's eligibility and avoid issues of definition of "immediate" family.]

Article XIII. COMPLIANCE WITH SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE OF 1954

- 1. Yale University Women's Organization is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 2. No part of the net earnings of Yale University Women's Organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.
- 3. No substantial part of the activities of Yale University Women's Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(d)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 4. Upon the dissolution of Yale University Women's Organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be disposed of by a court of competent jurisdiction of the State of Connecticut, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

[*Purpose of change*: To modernize and adopt the current approved Internal Revenue Service language; to eliminate references to purposes which are not congruent with YUWO's purposes; and, in section 4., to put the onus to make any decision (although the Board theoretically would have made such distributions in advance of dissolution in any event) where it would logically and legally belong, with a Connecticut court, rather than a Connecticut Supreme Court Justice.]
